AND ORDER

The above-entitled matter having been heard by and submitted for decision to Thomas J. Heslin, Workers' Compensation Administrative Law Judge, Findings of Fact and Award are made as follows:

FINDINGS OF FACT

- 1) Lien claimant, Khalid Bashir Ahmed M.D. has failed to prove his lien;
- 2) 2) Lien claimant, Quality Interpreting, has failed to prove its lien.

ORDER

IT IS HEREBY ORDERED THAT:

- 1) The lien of Khalid Bashir Ahmed M.D. be and herby is disallowed in full;
- 2) The lien of Quality Interpreting be and is hereby disallowed in full.

OPINION ON DECISION

This matter proceeded to lien trial on 12/16/2015. At the time of trial defendant timely objected to the admission of trial exhibits filed by lien claimants, Khalid Bahsir Ahmed M.D. and Quality Interpreting on the grounds that they were not timely filed and served in compliance with the Minute Order and Stipulations and Issues of 4/20/2015,


which ordered that exhibits be filed and served 20 days prior to the trial date of 6/22/2015. Neither lien claimant filed or served their exhibits until October 2015.

Defendant's objection was sustained and the trial exhibits of both lien claimants were excluded. Defendant withdrew its exhibits.

No live testimony was presented by either party.

There being no evidence to support the liens of either lien claimant the liens are hereby disallowed.
