INJURY AOE/COE

The court does not find the applicant's testimony to be credible with regard to the mechanism of injury. There were several inconsistencies in his version of how the injury occurred. Moreover, his version of how the injury occurred was contradicted by the emergency room report. In addition, applicant's witness stated he witnessed the reporting of the injury *before* the injury had even occurred. It is found that the applicant did not sustain industrial injury to the neck, shoulders, bilateral upper extremities and bilateral lower extremities.
