# **OPINION ON DECISION**

#### STIPULATED FACTS

Rosalinda Sanchez, born 6/11/1969, while employed during the period of 1/1/2007 through 10/24/2015, claims to have sustained injury arising out of and in the course of employment to the back, neck, bilateral wrists, upper extremities, excretory, hypertension, psych, and sleep. At the time of injury, the employer's workers' compensation carrier was Enstar for Starstone National Insurance Company, formerly known as Torus National Insurance Company.

#### THE SOLE ISSUE IS:

1. Whether or not Defendant Windsor Terrace Westlake Village will be allowed to take volume three of applicant's deposition. A finding will be based upon the parties' trial briefs in EAMS, both dated May 27, 2020.

#### DISCUSSION
