The above entitled matter having been heard and regularly submitted. The parties stipulated that ANGELA BROCK while employed during the period of March 1, 2020 through July 20, 2021 as a Bookkeeper/Business Manager, occupational group number 112 at Santa Barbara, California by Jessie Hopkins Hinchee Foundation, who was insured by National Casualty Company administered by Illinois Midwest did not sustain injury arising out of and in the course of her employment to her psych, anxiety, high blood pressure, sleep nervous system, circulatory system and other body systems.

With regard to the issues submitted for decision, the Honorable Stefanie Ashton, Workers' Compensation Judge, now decides as follows:


**FINDINGS OF FACT**

1. Lien Claimants Exhibits 1 through 7, marked for identification only, are inadmissible.

2. Lien Claimant did not meet its evidentiary burden of proof to recover on its lien associated with the medical-legal evaluation and reporting associated therewith conducted on April 5, 2022.

**ORDER**

- A. Lien Claimant shall recover nothing by way of its lien.
